

# Charity Cup Waiver

September 2025

This agreement is entered into by the participant and/or the parent(s) or legal guardian(s) of the participant (if under 18 years of age) in consideration for being allowed to participate in ice hockey camps, clinics, training sessions, and related hockey games and activities operated by **CoachMini, LLC and / or Stephen Minichini** and its affiliates.

## 1. WAIVER AND RELEASE OF LIABILITY

The undersigned voluntarily acknowledges and accepts all risks associated with ice hockey and related activities, including bodily injury, property damage, permanent disability, emotional trauma, or death. The undersigned, on behalf of the participant and their heirs, assigns, and legal representatives, **waives, releases, and discharges** CoachMini, LLC, Stephen Minichini, all staff, volunteers, affiliates, sponsors, host facilities, and any associated persons or entities (collectively "Releasees") from any and all claims, liabilities, or causes of action of any kind—including those arising from **negligence, gross negligence, or alleged acts of sexual abuse or misconduct**—that arise from or relate to participation in camp activities.

## 2. SEXUAL MISCONDUCT AND ABUSE DISCLAIMER

The undersigned acknowledges that CoachMini, LLC and Stephen Minichini maintain a **zero-tolerance policy** toward any form of sexual misconduct, harassment, or abuse. The participant and their guardians understand and agree that we:

- comply with mandatory reporting laws and will report suspected abuse to proper authorities.
- may screen and conduct background checks on staff and volunteers, but cannot guarantee the actions of others.
- By signing below, the participant (and parent/guardian) agrees not to hold CoachMini, LLC, Stephen Minichini or its representatives, liable for any actual or alleged incidents of abuse committed by third parties, participants, or others.

## 3. INDEMNIFICATION

If any claim is made or lawsuit brought against CoachMini, LLC or Stephen Minichini or the Releasees related to the participant's conduct, injuries, or actions, **including but not limited to allegations of abuse, harassment, or misconduct**, the undersigned agrees to **indemnify, defend, and hold harmless** the Releasees from any resulting losses, costs, or damages, including attorneys' fees.

## 4. ASSUMPTION OF RISK

The undersigned understands the inherent risks of ice hockey and camp-related activities, including physical contact, puck strikes, falls, equipment failure, and conditions of rinks or training areas. These risks may be caused by participants, coaches, equipment, or facility conditions and are assumed voluntarily.

## 5. HEALTH & FITNESS CERTIFICATION

The undersigned certifies that the participant is in good physical and mental health and has no condition that would impair participation. Any known conditions must be disclosed in writing prior to participation.

## 6. USE OF LIKENESS

CoachMini, LLC and Stephen Minichini has the right to photograph, videotape, and use the participant's image or likeness in promotional materials, social media, and digital content without compensation or further permission.

## 7. SEVERABILITY & GOVERNING LAW

If any part of this waiver is found to be invalid under law, all remaining provisions shall remain enforceable. This agreement shall be governed by the laws of the State of Connecticut, and any disputes shall be resolved in a court of competent jurisdiction in Fairfield County.
